For me, in this moment, 10 key words that might be tied to adult education are the following: Community, solidarity, movement, organization, leadership, transformation, participation, counter-hegemony, global citizenship and conscientization.

Do we have any thoughts that converge? Diverge? I feel like too much time over the past two years has been spent interacting with our computers. Too little with each other. Yet, we need our interactions and our time to play – even if in subtle ways.

#### THE BOARD OF DIRECTORS

The Board has met a few times since the AGM last spring. Our primary activity has been planning for CASAE's annual conference which will occur along with Congress in 2022. The regional activities have been few, but we hope to see that ramped up in the winter months. Finally BC region is not represented on the Board so if there is someone wanting to come forward or a nomination in the waiting, let us know.

#### **CASAE ANNUAL CONFERENCE and CONGRESS**

The Federation of Social Science and Humanities (the folks who organize Congress) were slow off the mark and then the message was "hurry up and catch-up." We settled on the dates of May 15-17 for CASAE's conference; the dates correspond with CSSE and CSSHE with whom we have reciprocal arrangements so we can attend each other's sessions. The Call for Proposals has a deadline of Dec 17, 2021 so please get your proposal for a paper, a panel or a roundtable in soon (see the Call in this newsletter). Note that with a decolonizing theme, Black and Indigenous students do not have to pay registration fees for CASAE or for Congress.

Finally, here are a few other messages of note:

#### Our Call for Pre-Conference Sessions is open now.

Normally, we include some thematic pre-conference sessions. In the past, they have varied in length and are a way to engage our group in a sometimes more informal forum leading up to the conference. If people are interested in convening a pre-conference session for the dates of May 13th to 15th, please submit a 250 work proposal to either of us (<a href="mailto:cindy.hanson@uregina.ca">cindy.hanson@uregina.ca</a> or <a href="mailto:rmcgray@brocku.ca">rmcgray@brocku.ca</a>). Please note if any fees or supplies are required as well as the length of the session (2 hours, morning, two day, etc.). Please submit this by Jan. 20th, 2022.

#### And so is Congress' call for Interdisciplinary Sessions

If you are interested in working with another association to host an interdisciplinary session, please be aware that there is funding of up to \$2000 available from the Federation's Aid for Interdisciplinary Sessions Fund. These sessions are open to the public as one of the criteria. Applications for Interdisciplinary funds are due Jan 31, 2022.

#### Also the Call for Hosts for CASAE National Conference 2023

The executive is interested in discussing with groups or individuals interested in hosting the 2023 CASAE National Conference (I know, it seems like a long way away!). Normally, this is discussed at the AGM, so we wanted to start to gauge interest about a potential host.

# CASAE/ACÉÉA 2022 Annual Conference Call for Proposals

#### **Submission Deadline: 17 December 2021**

The Canadian Association for the Study of Adult Education invites you to submit a proposal to present at our 2022 Annual Conference. CASAE accepts proposals from scholars, students, and practitioners from around the world. The 2022 conference will be an online conference in association with the Congress of the Humanities and Social Sciences.

Proposals are peer reviewed and authors of accepted abstracts are expected to submit a paper for inclusion in the conference proceedings. Collaborative sessions are encouraged. Please note that any individual can be sole or lead author on only one proposal.

#### **Types of Proposals and Sessions**

**Full Paper**: Full papers report on empirical work completed or well underway, explore theorization, or engage in a substantive analysis of the literature. Full papers (maximum 3,000 words not including references) are published in the conference proceedings.

**Research Roundtable**: Research roundtables provide an opportunity to discuss research in progress or theoretical or methodological issues. Roundtable papers (maximum 1,000 words not including references) are published in the conference proceedings.

**Symposium**: In a symposium, a group of three or more delegates present and discuss diverse or conflicting perspectives on a topic of interest to adult education practitioners and scholars. Symposium papers (maximum 4,000 words not including references) are published in the conference proceedings.

Typical information to include in proposal submissions are relationship to relevant literature, theoretical/conceptual framework, findings (if research-oriented), and implications for adult education. A list of sources referred to is not necessary in a proposal, but in-text citations should be included.

#### **How to Submit Your Proposal**

Paper, roundtable, and/or symposium proposals should meet the following criteria:

- · 500 words in length
- include a header if longer than one page
- · in Word or compatible format
- · contain the full title of the proposal
- · not include information that might identify the author or author affiliation

The following information is required in your submission:

- full title of your proposal
- · names, affiliations, and e-mail addresses of all authors, with the lead author designated as such.
- the following warrant statement (to be pasted into the "Comments for the Editor" box on the first step of the submission):

I/We warrant that if my/our paper/roundtable/symposium proposal is accepted, I/we will submit a paper for inclusion in the conference proceedings. I/We agree that the paper will be no more than 3,000 words (for full papers), 1,000 words (for roundtables) or 4,000 words (for symposia).

I/We understand that if this paper is not submitted by April 1, 2022 my/our presentation will not be included in the CASAE 2022 conference or its proceedings.

Throughout the day the attendance varied between 80 and 100 participants who contributed questions and reflections about the legacy of Paulo Freire. The event was a great success!

We just have words of gratitude to everyone who made this celebration possible. Thank you for the gifts that you have given us with your participation, for sharing your stories, for resisting with us and for keeping Freire's legacy alive. It was an occasion of coming together in community that went beyond barriers of language and pandemic restrictions.

In professor Hamalian's beautiful closing words,

"When you get despondent, remember that we have struggled before, we have survived, and we are going to struggle again, and make life much more inclusive and as we ride the waves ... looking as if they are going to topple us but then we are going to land in a much better place if we do it together if we hold hands ...each other's hands going towards more and more inclusion enlarging the circle ... as we walk

together ... we celebrate being together, and remember that we can act and we can get results if we are together!".

# **Building Trust Between Marginalized Communities and the Police: A Conversation with a local Police Chief**

"In a webinar entitled *Building Trust Between Marginalized Communities and the Police: A Conversation with a local Police Chief* (November 19, 2021), Professor Ghada Sfeir interviewed Police Chief Fady Dagher (Longueuil Agglomeration) about the success of his immersion training program to build bridges between the police force and the communities they serve. His officers who participate in this training program have to spend five weeks with the marginalized families they serve in the community, without weapons or uniforms, in order to build healthy relationships based on trust, empathy, and awareness of the individual and collective struggles of marginalized groups. Police Chief Dagher "aspires to fostering a culture change in his organization through the establishment of a model of a "Police de Concertation", a form of police service whose philosophy is to focus on prevention by supporting and acting on the spot with its citizens and partners.

The success and impact of this webinar is already evident in the recent approaches to policing in Montréal and Winnipeg, among others, as covered by the several Canadian media.

#### **ICÉA News**

#### Daniel Baril elected for a second term as President of UIL

During a meeting held on 25 and 26 November 2021, the members of the board of directors of the UNESCO Institute for Lifelong Learning elected for a second term Daniel Baril as president from the administration board.

This new mandate will be particularly marked by the holding of <a href="the-seventh UNESCO International Conference on Adult Education">the Seventh UNESCO International Conference on Adult Education</a> (CONFINTEA VII) and the launching of UIL's new 2022-2029 strategic planning. Likewise, the repercussions of the health crisis on adult education in UNESCO's member states will also be an issue of this second term.

During his first mandate, Daniel Baril had the opportunity to participate in UIL's reflection on the future of lifelong learning, a work which gave rise to a policy document proposed by UIL to UNESCO's International Commission on the Futures of Education. Within the framework of this work and, more broadly, in relation to the action of UIL, Daniel Baril emphasized the interest of taking into account the new emerging realities of adult education. In this context of accelerated transformation of adult education, Daniel Baril more particularly emphasized the relevance of updating the right to education to take into account the diversity of social demands for knowledge and skills as well as the multiplication places of learning and education. This second term as President of UIL allows Daniel Baril to continue to make a Quebec and Canadian voice heard in the international debate on adult education and within UNESCO. For the ICÉA, this participation in UNESCO's work is part of a commitment spanning several decades.

#### Congratulations Dr. Constanza Helen Silva!

Dr. Silva has been awarded a doctoral degree in the Philosophy of Education at Concordia University. Her thesis, titled Translating actor-network theory: A methodology for the analysis of news stories on massive open online courses from the International New York Times 2012-2015, translates principles from Bruno Latour's actor-network theory (2005) into a workable approach for the analysis of a controversy as expressed in news stories. Dr. Silva is a member of CASAE/ACÉÉA and has participated on the board as Quebec regional representative (2017-8, 2018-9). The dissertation will be published in the spring 2022.
